132/10 Recruitment of new Lengthsman

It was RESOLVED to engage the services of Euxton Parish Council's Lengthsman Hire Service for a trial period of three months. The hours would be commensurate with ensuring that there would be no increase beyond the weekly sum budgeted for Lengthsman services. It was further RESOLVED that the Parish Plan Sub Committee would consider a permanent arrangement for the work to be undertaken by a Lengthsman and how best this could be met and report back their recommendations to the Parish Council at a later date.

The meeting noted the sad loss of Mr. Gordon Gregg. He had been the Parish Clerk for many years and had contributed to Bretherton village life in numerous ways. He will be greatly missed.
